The PFJF Movement opposes unnecessary censorship, suppression of peaceful expression, and the concentration of power that allows governments, corporations, religious institutions, or ideological groups to silence dissenting voices.

At the same time, freedom is not absolute. Freedom without responsibility can become exploitation, corruption, violence, or tyranny. One person's liberty cannot come at the destruction of another person's fundamental rights or human dignity.

Therefore, the PFJF Movement supports limits on actions that:

- Promote or commit violence against others
- Involve coercion, slavery, trafficking, or exploitation
- Destroy democratic participation and free elections
- Spread deliberate fraud or corruption for harmful purposes
- Create monopolies or systems that eliminate fair opportunity

- Harm the basic rights, safety, or freedom of other human beings

The PFJF vision of freedom is rooted in nonviolence, fairness, open inquiry, voluntary cooperation, compassion, and equal human dignity. We seek a world where people are as free as possible while still protecting justice, peace, and the rights of all.

“Maximum freedom consistent with nonviolence, justice, fairness, and the equal rights of all people.”

“People should be free to think, speak, create, trade, and live as they choose, so long as they do not violate the rights and freedom of others.”
